

# **Learning from Safeguarding Adults Audit 2019**

The Section 11 and Safeguarding Adult Audit process evidenced that the majority of organisations in Calderdale described effective safeguarding practice for children and adults.

There were many examples of good practice, and some areas identified for improvement. This crib sheet provides assistance to organisations to improve safeguarding practice further. It includes resources, policies, procedures and training opportunities related to the identified topics.

This crib sheet is split into three areas: The first section is applicable to both adults and children's safeguarding; the second is for solely adult services and the third is for child services only.

# Section 1: Safeguarding Children and Adults

## **Transition**

Some evidence was provided about transition between services, but little evidence was given about evidence of safeguarding transition between children and adults services. Some feedback showed that information sharing is key for more effective transitions. A good example is the Joint National Protocol for the Youth Offending Team and the National Probation Service.

The CSAB and CSCP will be undertaking a Holistic Report on Transitions at the end of 2020 to identify good practice, gaps and areas for development.

## Mental Capacity Act 2005 for Adults and 16-17 year olds

Awareness needs to be raised about the MCA 2005 and its applicability to 16- and 17-year olds. In addition, there is national and regional work underway to make this clearer.

# **Section 42 Understanding**

The implementation of the S42 criteria has been under much scrutiny from a national level in 2019: there are differences in the way that Local Authorities implement the criteria when concerns are received. A significant amount of work has been underway in the Yorkshire and Humber region to enable a shared regional understanding of Section 42 criteria.

A framework for making decisions on the duty to carry out safeguarding adults enquiries

#### **Homelessness**

Homelessness features in the current CSAB Business Plan 2020 – 2023, after a thematic review on people who lived street based lives: 'Burnt Bridges' was conducted in 2019.

Only a Housing Service provided evidence of how they safeguard homeless people; more organisations need to be aware of, and know how to support adults who are experiencing homelessness or people who live street-based lives. The SAB will be looking on more detail at the findings from this review and how the multi-agency partnership can support adults at risk.

## Specific areas of vulnerability for Adults

We received some good evidence about the work being done in Calderdale in specific areas including: Missing Persons, Learning Disabilities / Difficulties, Memory and Cognitive Deficits, Mental Health, Substance Misuse and Self-Neglect. However, evidence showed that improved partnership working was needed to expand the knowledge about the voice of the adults who have the vulnerabilities.

# Part 3: Safeguarding Children

# **Online Safety**

Some partners identified that there was a gap in their Online Safety knowledge and intervention. Some organisations have policies in place around Online Safety, but not all. A good example was provided from an education setting about a web based product which monitors traffic (for staff and students) and identifies key words that may indicate that safeguarding support is needed (based on nationally provided guidance).

The CSCP has prioritised online safety and will be taking a closer look at how children are safeguarded online through Holistic Reporting.

# Child Exploitation and Harmful Sexual Behaviour

There is a large amount of evidence about good practice and partnership working for Child Exploitation but there are constant changes to practice and guidance which services and practitioners need to keep up to date with. The move from Child Sexual Exploitation to include wider forms of abuse including gangs, knife crime, cross border activity and drug related crime are areas for development for some organisations to ensure these are included within their policies and procedures.

# **Mental Health**

Some evidence was given about the support given to children and families due to the mental health issues of parents, which was an issue recently identified in a Calderdale Serious Case Review. Child mental health is an area where lots of changes are being made to local and national organisations which agencies need to keep abreast of.
